1 PDD-02-2019 Recreational Cannabis Retail Stores in Haldimand County

M. Ferris provided an overview of the staff report presented at the January 15, 2019 Council in Committee meeting.

Marta Vartanian spoke in support of the County opting in as a means to bring money into the community and to provide a safe source of cannabis.

Mary Beth Williamson spoke in support of opting in. She noted that she works for a company in the cannabis business and that local retail opportunity will prevent people from buying on black market from non regulated sources.

Barb Roth spoke in opposition to opting in and voiced concerns that opting in would have a negative impact on the community.

Bubba Nicholson spoke in support of opting in. He advised that regulating cannabis ensures quality of product. He shared his personal experience with cannabis and how it improved his life after surgery and chronic pain.

Ann Baldwin spoke in opposition to opting in. She noted that residents can already obtain cannabis legally online. She supports legalization but is concerned about the potential social impacts of opting in.

John Walker advised that he was neutral on whether to opt in or not. He asked for a recorded vote.

Tiffany (last name not provided) advised that she is a business owner within the County and would be interested in investing in a cannabis business.

Geoff Hoover advised he first used cannabis after an accident. He noted how cannabis oil helped him in his recovery and with pain management.
