1 Discussion Re: Enforcement of Cannabis

It was noted that additional monies will be provided by the Province to cover the costs of enforcement, public education and other matters related to the legalization of cannabis. Discussion ensued regarding the licensing of retail stores and availability of field sobriety and drug recognition officers.

The Board was advised that the November reports were skewed due to significant enforcement in the area; therefore, no recent reports have been circulated. The December reports will be circulated in the near future. Discussion ensued regarding enforcement, use of data, and photo radar.

Inspector Carter advised the Board that there are two ongoing investigations regarding the Pride Day incidents. Discussion ensued regarding more effective arrangements for this year's event. County staff are looking into permit options for the group.
