CALL TO ORDER

Councillor Shirton called the Council in Committee meeting to order at 9:30 a.m.

2 PDD-11-2019 General Zoning By-law Amendment for Cannabis Production Facilities, Haldimand County

M. Ferris provided an overview of the subject report and recommendations. She noted that the report presents the finalized by-laws pertaining to production facilities and clarified that the County does not have jurisdiction over matters pertaining to odour control. If approved by Council and pending no appeals, the subject zoning provisions would come into effect as of April 23, 2019.

Diane Jamieson, noted concerns related to the impact that nearby permitted operations will have on home values and the lack of information available to residents.

Mike Paquette, expressed concerns related to the lack of information surrounding the neighbouring permitted facilities. He requested residents of the area be provided with site plan details so they can understand how the facility will affect the use of their property in regards to lighting and odour.

Susan Milligan, resident in the Moulton area, praised the County for moving forward with the subject zoning by-law amendment.
