# 1 Proposed Changes to Speed Sign Protocol

T. Haedrich reviewed the proposed changes with the Board, noting that there is strong Council support to purchase more devices in 2020. Staff are recommending that the portable trailer mounted device be located based on ward councillor input and consecutively cycle through each ward. An increase in the duration of deployment for each device was also proposed. The Board recommended that the O.P.P. be consulted on deployment locations, in conjunction with staff and Ward Councillor. The O.P.P. will circulate the 2018 traffic complaints to the Board and County staff to assist in determining locations. The amended speed sign protocol will also be circulated to the Board after its presentation to Council.
