He requested that meetings with the owner be more widely publicized in the media and requested Council's support in bringing forward a solution for residents, as attempts to address the issue with the Ministry of Environment have been unsuccessful.

A compliance order has been issued to remove the leachate from site and the company is working to comply with this.
