Concerns were expressed regarding the escalating situation in Caledonia and the Board's statement released at the September 23, 2020 meeting. It was noted that the new Community Safety and Policing Act mandates human rights, systemic racism, diversity and Indigenous training for all Board members. The Board will fully embrace this training once it has been established.
