 - g. Final approvals from the Haldimand-Norfolk Health Unit related to food premises and portable toilets are obtained;
 - h. Confirmation that security staff will be on location for the entire event from when gates open until participants have left the property;
 - i. Written proof that the Applicant has advised neighbours of the proposed event;
 - j. Provision of a certificate of a Commercial General Liability Policy of insurance with an insurer licensed to do business in the Province of Ontario providing coverage for bodily injury and property damage in an amount not less than \$5,000,000 per occurrence, written on an occurrence basis, containing a cross liability/severability of interest clause, provide for 30 days written notice of cancellation and naming Haldimand County as an additional insured;
 - k. A damage deposit in the amount of \$5,000 be provided for any municipal costs for damages to municipal property or cleaning of municipal property;
 - I. In the event of unfavourable weather requiring postponement, any subsequent date/location will be required to meet the same conditions as noted above with approval by County officials;

- m. A revised site plan be submitted to ensure that the lantern release, flame out, descent and ember process, and a buffer zone, is contained within the Dunnville Airport property;
