J. NEW BUSINESS

1 Verbal Update RE: Results of May 2-3 Safety Blitz along the Highway 6 Corridor

The Haldimand County OPP Detachment joined with the Burlington OPP, Wellington County OPP, Ministry of Transportation, and Ministry of Finance to patrol the Highway 6 corridor. Inspector Carter advised the Board that it was a great success with a number of charges and tickets laid. Another blitz is anticipated to take place in the fall.

Verbal Update RE: New Policy Requirement for Use of Board Resources During an Election Period

Due to recent amendments to the Municipal Elections Act, local boards of Council now require a policy to establish rules and procedures with respect to the use of municipal resources during an election period. K. General advised that County staff are recommending an amendment to our existing Election Protocol Policy to include local boards of Council. A report will be going to the June 5, 2018 Council in Committee meeting for Council consideration. The amended policy will be placed on the June 27, 2018 meeting for information.

3 Interpretation of Speed Spy Reports

Discussion ensued around the interpretation of speed spy device reports. It was clarified that these cameras are placed in areas that have higher rates of both speeding and collisions.

4 Update RE: Zone 4 Meeting

The Board was provided with an update on discussions at the recent Zone 4 meeting related to Police Services Board members training and new legislation. Provincial grant programs were also highlighted.

5 Update RE: Gun Amnesty Program

Inspector Carter provided the Board with an update on the recent province—wide gun amnesty program that was conducted by the OPP. The program ran from April 1st to 30th, 2018 and was a great success with a number of firearms, grenades, and ammunition surrendered to local detachments.

1 Chief Superintendent John Cain's Response to Questions Presented at the October 25, 2017 Meeting

The Board was advised that Chief Superintendent Cain is working with staff from Orillia to gain clarification on questions. It was noted that the goal of these questions was to provide the Board and local detachment with an opportunity to understand how policing functions in local control with the intent to improve the business relationship and understand mutual perspectives. The Board requested that correspondence be sent to the Chief Superintendent and the item was moved forward to the June 27, 2018 meeting.
