

## THE CORPORATION OF HALDIMAND COUNTY

By-law Number /18

### **Being a by-law to authorize the sale of land on Concession 2, north of Dover Road, Dunn in Haldimand County**

**WHEREAS** the Corporation of Haldimand County declared the lands described as Part of Lot 7, Concession 2, north of Dover Road, Dunn, now Haldimand County (the "Lands"), to be surplus to the needs of the Corporation, in accordance with Haldimand County By-law No. 269/02;

**WHEREAS** the Corporation of Haldimand County deems it in the best interest of the Corporation to sell the Lands;

**AND WHEREAS** notice of the proposed by-law has been published in the local newspaper in Haldimand County which has a general circulation in the area of the subject lands,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** the Mayor and Clerk are hereby authorized to execute the appropriate documents to enable the sale of lands legally described as PIN # 38134-0201 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 7 on 18R9, Dunn, now Haldimand County; PIN # 38134-0212 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 18 on 18R9, Dunn, now Haldimand County; PIN # 38134-0214 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 20 on 18R9, Dunn, now Haldimand County; PIN # 38134-0227 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 33 on 18R9, Dunn, now Haldimand County; PIN # 38134-0228 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 34 on 18R9, Dunn, now Haldimand County; PIN # 38134-0244 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 50 on 18R9, Dunn, now Haldimand County; PIN # 38134-0248 (LT), Part Lot 7, Concession 2, north of Dover Road, being Part 54 on 18R9, Dunn, now Haldimand County; PIN # 38134-0214(LT), Part Lot 7, Concession 2, north of Dover Road, being Part 23 on 18R9, Dunn, now Haldimand County, and PIN # 38134-0219(LT), Part Lot 7, Concession 2, north of Dover Road, being Part 25 on 18R9, Dunn, now Haldimand County to 1541189 Ontario Inc., for the sum of Fifty Four Thousand Seven Hundred Eighty Dollars (\$54,780) plus applicable taxes.
2. **THAT** the Clerk is hereby authorized to affix the Corporate Seal to this by-law and to all other documents as required herein.
3. **AND THAT** this by-law shall come into force and take full effect from the date of passage thereof.
