By-law Number /18

Being a by-law to amend By-law 1942/18 to regulate the rates of speed in Haldimand County – Haldimand Road 9, (Empire Corners), King Street (Hagersville), McClung Road (Caledonia)

WHEREAS Section 27(1) of the *Municipal Act*, 2001, S.O. 2001, c. 25., as amended, authorizes municipalities to pass by-laws in respect of a highway under its jurisdiction;

WHEREAS in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 1942/18 to regulate different rates of speed for motor vehicles driven on a highway or portion of a highway in Haldimand County;

AND WHEREAS the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 1942/18 with respect to the maximum rates of speed on Haldimand Road 9 in Empire Corners, King Street in Hagersville and McClung Road in Caledonia,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule "A" of By-law 1942/18 be amended to repeal the following sections:

2. **THAT** Schedule "A" of By-law 1942/18 be amended to add the following sections:

Haldimand Road 9	A point 465 metres east of Haldimand Highway 56	Singer Road	60 km/h
Haldimand Road 9	Niagara Region Boundary	465metres East of Haldimand Highway 56	80 km/h
King Street East	Main Street	825 metres east of Parkview Road	50 km/h
McClung Road	Caithness Street	Haldimand Road 66	60 km/h

- 3. **THAT** this by-law shall take precedence over any other by-law with which is inconsistent.
- 4. **AND THAT** this by-law shall cone into force and take effect when signage applicable to this provision has be installed and is on display.
