Being a by-law to amend By-law 307/02 to regulate parking in Haldimand County - Hagersville

WHEREAS Section 10 of the Municipal Act, 2001 S. O. 2001 c. 25, as amended ("the Act") provides that at single-tier municipality may pass by-laws respecting any services or thing that the municipality considers necessary or desirable for the public;

WHEREAS in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 307/02 to regulate and govern traffic ad the parking of vehicles on private or municipal property in Haldimand County;

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:
