THE CORPORATION OF HALDIMAND COUNTY

By-law Number /18

Being a by-law to authorize the stopping up, closure and sale of Parts of the road allowances known as Britannia and Onondaga Streets in Cayuga, now in Haldimand County and being Parts 2, 3 & 5 on 18R-7690

WHEREAS that portion of the unopened road allowances known as Britannia and Onondaga Streets in Cayuga, now in Haldimand County, being Parts 2, 3 & 5 on Reference Plan 18R-7690, (the "Land") is not required for vehicular or pedestrian traffic and has been declared surplus to the requirements of The Corporation of Haldimand County;

WHEREAS the Council of The Corporation of Haldimand County deems it expedient to stop up, close and to sell the soil and freehold of the Land in accordance respectively with Section 34 and 270 of the Municipal Act, S.O. 2001, c.25, as amended;

WHEREAS notice of the proposed by-law has been published in Haldimand County in local newspapers which have a general circulation in the area of the above-mentioned Land;

AND WHEREAS the effect of the passing of this by-law will not deprive any person of the means of ingress and egress to or from such person's lands or place of residence,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. **THAT** the road allowance known as Part of PIN # 38224-0258(LT), being Part of Britannia Street, Township of North Cayuga West of Grand River, designated as Part 5 on 18R-7690, Haldimand County; Part of PIN # 38224-0259(LT), being Part of Onondaga Street, Township of North Cayuga West of Grand River, designated as Part 3 on 18R-7690, Haldimand County; and PIN # 38224-0260(LT), being Part of Britannia Street, Township of North Cayuga West of Grand River, designated as Part 2 on 18R-7690, Haldimand County is hereby stopped up, closed and sold to the abutting landowners, Frederick Smith and Betsy Smith, for Three Thousand Four Hundred Fifty Dollars (\$3,450.00) plus HST and all costs of closure and conveyance.
- 2. THAT the Mayor and Clerk of Haldimand County are hereby authorized and instructed to execute the necessary documents required to give effect to the intention herein, and the Clerk of Haldimand County is hereby authorized to affix the Corporate Seal of the Municipality to this by-law and to all other related documents as may be required.
- 3. **AND THAT** the Clerk is hereby instructed to register a copy of this by-law, certified under her hand and the seal of the Municipality, in the Land Registry Office for the Registry Division of Haldimand, pursuant to Section 34 of the said Municipal Act.

READ a third time and finally passed this 17th day of December, 2018.
