Report CLS-02-2019 Citizen Appointments to Haldimand County Boards and Committees

OBJECTIVE:

EXECUTIVE SUMMARY:

With the start of a new term of Council, the County's various boards and committees require the appointment of citizen members in accordance with applicable legislation, by-laws and Terms of Reference. The appointments are necessary to ensure these bodies can continue to fulfill their mandates over the course of the next four years. Participation on a board or committee provides citizens with the opportunity to more actively engage in their local government. This works to strengthen community relationships and creates a mechanism for open and meaningful dialogue on municipal issues thereby enhancing the quality of life that Haldimand County residents enjoy.

BACKGROUND:

The recruitment process for the County's boards and committees occurs every four years coinciding with the start of a new term of Council. Recruitment opportunities are advertised on the County's website and through various other mediums including social media and local newspapers. Interested citizens are invited to submit an application for as many boards and/or committees as they would like to be considered for and have the option to attach a resume highlighting their previous experience and qualifications that pertain to the boards and/or committees of interest to them.

Throughout the month of November 2018, the County advertised the various opportunities available. A description of each board and committee was included on the County's website along with a link to the relevant Terms of Reference. The County received a very positive response to its recruitment efforts with over 100 individuals submitting applications expressing interest in serving on one or several of the County's boards and committees.

The citizen appointment to the Police Services Board was approved at the January 21, 2019 Council meeting through Report CLS-01-2019 and is therefore not included within the scope of this report.

ANALYSIS:

The process and evaluation criteria for the appointment of citizens to the County's various boards and committees was approved by Council at its December 17, 2018 meeting through Report CL-12-2018 and is summarized as follows:

Step 1	Initial Screening of Applications	To be completed by Manager(s) and designated staff along with the Council Members who are Chair and Vice Chair of the relevant Business Division and the Mayor at his discretion
Step 2	Interview Process (Optional)	Dependent upon the number of applicants relative to the spaces available on the board or committee
Step 3	Recommendations to Full Council	Panels to forward their recommendations for inclusion in a report to Council in Committee

Using the process and evaluation criteria, applications were screened and selection recommendations were made by the panels based on the applicant's knowledge of the role, relevant skills and experience, expressed dedication / commitment and time availability. An additional key concern in the selection process was ensuring that board and committee appointment recommendations, where possible, reflected geographic representation from across the County.

A brief description of each board and committee is provided below. To ensure transparency and accountability in the recruitment process, the names of all applicants and the boards and/or committees to which they have applied are provided below. All individuals have been notified of staff's intent to publish their names within this report. Attachment 1 to this report provides additional information concerning the membership composition, meeting cycle and legislative authority for the County's boards and committees and identifies departmental responsibility for each.

Names of the recommended appointees, along with their applications, are provided in confidential memorandum CLS-M02-2019 in order to maintain privacy. Consideration of the applications should take place in closed session on February 5th, with the recommendations outlined in this report subsequently voted on in open session.

Accessibility Advisory Committee

This committee is a key resource and contributor to accessibility planning issues in all Departments of Haldimand County including providing advice on building, recreational and facility design matters, communication practices and transportation matters. The Haldimand County Accessibility Advisory Committee (HCAAC) promotes a barrier-free environment for all persons, regardless of needs, to participate as fully as possible in all aspects of community life. The *Accessibility for Ontarians with Disabilities Act, 2005* (AODA) legislates that the majority of HCAAC members shall include persons with disabilities. The AODA defines disability as: physical (includes visual, speech, hearing, deaf, brain injury, requirement to use a wheelchair); mental impairment or a developmental disability; learning disability; and mental disorders.

In reviewing the HCAAC Terms of Reference, it was determined that a housekeeping amendment is required to adjust the number of members to reflect the current 6 citizen members, plus one council appointee. Staff had previously been included in the membership numbers, and should be considered as liaison and resources for the committee as opposed to forming part of the membership. Also, the Terms of Reference currently requires that committee members be at least 18 years of age. In reviewing applications, there is interest from an individual who is younger than 18, and as the review panel felt that it would be a positive addition to have youth representation on the committee, removal of the age limit is included in the report recommendation.

The Accessibility Advisory Committee selection panel has recommended six individuals for appointment, which would fulfill the full membership complement of the committee.

Agricultural Advisory Committee

The committee advises Council on matters, issues and policies pertaining to agriculture and agribusiness within Haldimand County. Membership includes two representatives from the Haldimand Federation of Agriculture; two representatives from the Christian Farmers Association; a representative from the Agri-business community at large; and local farmers with a variety of farming backgrounds as well as youth.

The Agricultural Advisory Committee selection panel has recommended 8 individuals for appointment, which would fulfill the membership complement of the committee.

Business Development and Planning Advisory Committee

This committee offers advice and perspective on what is happening within the business community and provides feedback on the success of Haldimand County's Economic Development and Tourism strategies. The committee provides input on the proposed annual divisional work plan and advice on strategic initiatives undertaken to promote business and tourism investment. It also works with staff to promote the County to prospective clients to demonstrate alignment between local government and the business community. As the County's statutory Planning Advisory Committee, it provides advice/input into major strategic planning initiatives that will have an impact on economic development within the County such as land supply, servicing strategies and Official Plan updates.

In response to the significant community interest in this committee, while maintaining a reasonable size for logistical purposes, the selection panel has recommended that for the 2018-2022 term of council two additional citizens be included in the membership complement of the committee as community-at-large members.

The panel has recommended twelve individuals for appointment, which would fulfill the complement of the committee plus the recommended two additional members for this term of Council.

- the Sign Variance Committee wherein applications for relief from requirements of the County's Sign By-law are considered;
- the Property Standards Committee, which deals with appeals to Property Standards Orders to Remedy Violation of Standards of Maintenance and Occupancy pursuant to the Building Code Act: and
- appeals to the Animal Control By-law, specifically dog muzzle orders usually resulting from dog bites.

Beginning in the year 2020, Council approved the per diem of \$200 for citizen members be adjusted at the same percentage as is approved for increases to Council member's base remuneration, rounded to the nearest dollar.
