Report ECW-06-2019 Caithness Street West, Caledonia – Restricted Parking Zone

OBJECTIVE:

To receive Council approval to amend Haldimand County Parking Control By-law 307/02 to create a restricted parking zone in front of 5 Caithness Street West in Caledonia.

EXECUTIVE SUMMARY:

Staff have reviewed the existing restricted parking conditions and traffic flows on Caithness Street West just west of Argyle Street and are recommending that a no parking condition be implemented on the one parking stall in front of 5 Caithness Street West from 3 pm to 6 pm on weekdays to allow for more efficient traffic flow.

BACKGROUND:

Staff have received concerns from residents, through the local Councillor, regarding eastbound traffic flow on Caithness Street West in the afternoon. The concerns are attributed to the one parking stall in front of 5 Caithness Street West (see Attachment 1) which can prevent cars from making a right hand turn onto Argyle Street if several cars are backed up at the Argyle Street lights. Under the existing conditions 2 hour parking is permitted in this space from 8 am to 2 am.

ANALYSIS:

Based on a review of the traffic flows, as well as photos of the traffic conditions provided by the local Councillor, staff are recommending that this space be made no parking between 3 p.m and 6 p.m Monday to Friday to improve traffic flow at this location. Given the minor nature of the proposed change to the one parking space it is not anticipated that there will be any parking capacity issues in the area.

In order to create the required no parking restrictions the following changes to Haldimand County Parking Control By-law 307/02 are required:
