Report ECW-04-2019 Alma Street North, Hagersville – Removal of No Parking Zone



For Consideration by Council in Committee on March 26, 2019

OBJECTIVE:

To receive Council approval to amend Haldimand County Parking Control By-law 307/02 to remove the existing no parking zone on the west side of Alma Street North between King Street East and David Street in Hagersville.

RECOMMENDATIONS:

1. THAT Report ECW-04-2019 Alma Street North, Hagersville – Removal of No Parking Zone be received;
2. AND THAT Haldimand County Parking Control By-law 307/02, Schedule “C” No Parking – Hagersville, be amended as outlined in Report ECW-04-2019.

EXECUTIVE SUMMARY:

Staff have reviewed the existing parking conditions, traffic flow and road width on Alma Street North between King Street East and David Street and are recommending that parking be permitted on the west side of Alma Street North in order to create additional parking in this area.

BACKGROUND:

At the January 15, 2019 Council in Committee meeting staff were given direction through the following resolution:

“THAT staff be directed to report back to a future Council in Committee meeting on the feasibility of providing parking on the west side of Alma Street from David Street to King Street East.”

Under the existing conditions (see Attachment 1) Alma Street North extends from King Street East to Marathon Street. Parking is currently permitted on both sides of the street between David Street and Marathon Street and on the east side only between David Street and King Street East. The current road width is approximately 9.5 m along this section of Alma Street.

ANALYSIS:

Staff have reviewed existing parking conditions, traffic flow and road width along Alma Street North and given that the road is wide enough for two way traffic with parking on both sides, as well as the fact that both the Hagersville Public Library and Hagersville Legion are located on the west side of Alma Street,

are recommending that the no parking restriction on the west side of Alma Street North be removed to provide additional parking on the street.

In order to remove the No Parking Zone the following change to Haldimand County Parking Control By-law 307/02 is required:
