3 Monthly Report from the Detachment Commander

No dashboard or speed spy reports were available for circulation. Inspector Carter reviewed the February monthly reports with the Board, noting a slight increase in theft under and drug crime, and a decrease in break and enters, theft over and mischief. A decrease in year to date motor vehicle collisions and calls for service related to mental health, domestic violence, and 911 calls was also noted. The success of the recent distracted driving campaign held between March 11 to 17, 2019 was highlighted. The Board was also advised that the Ontario SPCA will be withdrawing their investigative services. The O.P.P. will be meeting with Municipal Enforcement staff to look into options. Discussion ensued regarding service complaints, statistics related to motor vehicle collisions, and naloxone kits. The Board requested that the O.P.P. share positive news stories with the community related to the decrease in calls for service.

- Reduction in accidents through visibility and enforcement;
- Place more emphasis on education and community awareness related to opioid/drug use, mental health, 911 calls/hang-ups; and
- Enhanced police visibility.

It was noted that the current objectives and priorities identified in the 2017-2019 O.P.P. Action Plan and Board Business Plan focus on similar items related to enhanced police visibility, support of the community street crime unit, highway safety and collision reduction, reduction in the incidence of violent crime and property crime. Discussion ensued regarding the upcoming safe on 6 initiative being held in May.

This item will be placed on the April 24, 2019 agenda for consideration of a motion for inclusion in the 2020-2022 O.P.P. action plan / board business plan.
