

## THE CORPORATION OF HALDIMAND COUNTY

By-law Number     /19

**Being a by-law to amend By-law 1942/18 to regulate the rate of speed on various roads in the area of Peacock Point in Haldimand County**

**WHEREAS** Section 27(1) of the *Municipal Act*, 2001, S.O. 2001, c. 25., as amended, authorizes municipalities to pass by-laws in respect of a highway under its jurisdiction;

**WHEREAS** in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 1942/18 to regulate different rates of speed for motor vehicles driven on a highway or portion of a highway in Haldimand County;

**AND WHEREAS** the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 1942/18 with respect to the maximum rate of speed in Haldimand County in the area of Peacock Point,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** Schedule "A" of By-law 1942/18 be amended to repeal the section as follows:

Highway	From	To	Maximum Rate of Speed
Carolyn Street	Lakeside Drive	David Drive	50 km/h
Fagan Street	Carolyn Street	Lakeside Drive	50 km/h
Howard Street	Lakeside Drive	East to end	50 km/h
Lakeside Drive	Wilcox Drive	South Coast Drive	40 km/h
Park Street	South Coast Drive	Semmens Street	50 km/h
Reidy Street	Fagan Street	Semmens Street	50 km/h
Semmens Street	Lakeside Drive	East to end	50 km/h
Wilcox Drive	Lakeside Drive	South Coast Drive	40 km/h
Witherspoon Drive	Lakeside Drive	South Coast Drive	40 km/h

2. **THAT** Schedule “A” of By-law 1942/18 be amended to add the section as follows:

Highway	From	To	Maximum Rate of Speed
Carolyn Street	Lakeside Drive	David Drive	30 km/h
Fagan Street	Carolyn Street	Lakeside Drive	30 km/h
Howard Street	Lakeside Drive	53 metres east of Park Street	30 km/h
Lakeside Drive	Wilcox Drive	South Coast Drive	30 km/h
Park Street	South Coast Drive	Semmens Street	30 km/h
Reidy Street	Fagan Street	Semmens Street	30 km/h
Semmens Street	Lakeside Drive	14 metres east of Reidy Street	30 km/h
South Coast Drive	South Coast Drive	Lakeside Drive	30 km/h
Wilcox Drive	Lakeside Drive	South Coast Drive	30 km/h
Witherspoon Drive	Lakeside Drive	South Coast Drive	30 m/h

3. **THAT** this by-law shall take precedence over any other by-law with which is inconsistent.
4. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision has be installed and is on display.

READ a first and second time this 15<sup>th</sup> day of October, 2019.

READ a third time and finally passed this 15<sup>th</sup> day of October, 2019.
