1 Monthly Report from the Detachment Commander

Inspector Carter reviewed the June, July and August monthly reports with the Board, noting a decrease in crime trends and an increase in 911 calls and fatalities related to motor vehicle collisions. The success of the Hagersville Crime Stopper's Program and a donation made to the Police Service Board were highlighted. Discussion ensued around police visibility. The Board requested that the foot patrol hours in Caledonia be increased. Concern was expressed regarding the lack of police presence in the community in the form of vehicles on the roads.

## H. UNFINISHED BUSINESS

1 Discussion Re: 911 Call Response Policy

It was noted that this is based on the Toronto policy and that they adhere to a separate system. The Board was advised that the O.P.P. have approached the Commissioner about changing the process. The current O.P.P. practice is to treat every call as an emergency.

2 Update Re: Service Availability

Discussion ensued around municipalities in Ontario wanting to opt out of the O.P.P. service provision due to lack of service availability. Issues around individuals eligible for retirement, on WSIB and other leaves of absence were noted as issues in terms of ensuring sufficient resources to provide adequate and effective policing. The Board noted its displeasure with the lack of service availability within the community.

3 Update Re: Provincial Appointment

#### I. NEW BUSINESS

1 Enforcement of Parking Restrictions near the Hagersville Quarry

It was noted that the County provided additional funds to do patrols on the weekend by way of paid duty officers. Municipal Enforcement Officers have also been working additional hours at the quarry.

# 2 O.P.P. Procedures Related to Outlaw Motorcycle Gangs

Discussion of this item stems from a recent incident in Caledonia. The Board was advised that the O.P.P. identifies gangs as organized crime; however, must have a lawful reason in order to stop these individuals.

# 3 Reactive versus Proactive Policing

Concern was expressed regarding the lack of police resources. It was noted that more can be done proactively in terms of media releases about fraud schemes. The Board expressed a desire to see the O.P.P. do more proactive policing in terms of foot patrols and visibility within the community.

# 6 Townsend Community Policing Funding Request Update

J. Whiting advised the Board that Community Policing Grant funding requested by the Townsend Community Policing Committee in the amount of \$1,760 has been issued to the Committee. K. Schmitz will report back on this request as well as Community Policing Committee activities at a future meeting.

# 7 Vagrancy and Protest Laws and Regulations

Discussion ensued regarding street preachers and protest groups in the Dunnville area. It was noted that an O.P.P. Community Liaison Officer is working with the individuals/groups. The feasibility of establishing a designated protest area was also noted.

# 8 Zone Meeting Update

An overview of the zone meeting was provided. Discussion ensued regarding legislation, demonstration, loitering, police availability, cannabis, and recruitment issues for both Section 10 and municipal police forces.

# 9 Spy Camera Results

Discussion ensued regarding the June, 2017 results for Cross Street West in Dunnville. It was noted that, once results become available, they are posted on the County website.

# 10 Rob Lamothe Pride Day Request to Speak

It was noted that Inspector Carter spoke with Mr. Lamothe last week whereby he expressed his appreciation for the Board's support in the pride day event.

# 11 O.P.P. Billing Statement

J. Whiting advised that she has received the billing statement for 2020, noting that the estimated billing is \$7.6 million which is a \$100,000 (approximately 3%) increase from 2019. It was noted that the reconciliation for 2018 will be \$125,000. Further information will come forward at the October 23, 2019 meeting.

# 12 Haldimand County Detachment 2018 Progress Report

Inspector Carter circulated this item to the Board. It will be placed on the October 23, 2019 meeting for discussion.

# 13 Argyle Street Bridge

It was noted that the Ministry of Transportation has confirmed that construction of the Argyle Street bridge will commence in the spring of 2020, with completion expected to occur in 2022. Concerns were expressed regarding potential protests. It was added that the Ministry has not been in consultation with local groups.
