

# THE CORPORATION OF HALDIMAND COUNTY

## **Being a by-law to confirm the proceedings of Council of The Corporation of Haldimand County**

**WHEREAS** the *Municipal Act*, S.O. 2001, c.25, Section 5, provides that the powers of a municipal corporation shall be exercised by its Council;

**WHEREAS** Sections 10(1) and 10(2) of the said *Municipal Act*, stipulate that a single-tier municipality may enact by-laws to provide any service or thing that the municipality considers necessary or desirable for the public;

**AND WHEREAS** in many cases action which is taken or authorized to be taken by Council does not lend itself to the passage of an individual by-law,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1.     **THAT** each motion, resolution and other action of the Council of The Corporation of Haldimand County passed and taken by Council at its meeting held on the 10<sup>th</sup> day of February, 2020 be and are hereby approved, adopted, ratified and confirmed.
2.     **THAT** the action of Council at its meeting held on the 10<sup>th</sup> day of February, 2020 in respect of each recommendation contained in the following minutes:
  - Council Minutes – January 22, 2020
  - Closed Session – Council Minutes – January 22, 2020
  - Committee of the Whole Minutes – January 28, 2020
  - Special Council Minutes – January 28, 2020
  - Council in Committee Minutes – February 4, 2020
  - Closed Session – Council in Committee Minutes – February 4, 2020

and in respect of each motion, resolution and other action taken by Council at the said meeting is, except where the prior approval of the Local Planning Appeal Tribunal or other authority is by law required, hereby approved, adopted, ratified and confirmed as if all such proceedings were expressly embodied in this by-law.

3. **THAT** where no individual by-law has been or is passed with respect to the taking of any action authorized in or by the above-mentioned minutes or with respect to the exercise of any powers by the Council in the above-mentioned, then this by-law shall be deemed for all purposes to be the by-law required for approving and authorizing and taking of any action authorized therein or thereby, or required for the exercise of any powers therein by the Council.
4. **AND THAT** the Mayor and the proper staff of The Corporation of Haldimand County are hereby authorized and directed to do all things necessary to give effect to the said action of the Council or to obtain approvals where required and, except where otherwise provided, the Mayor and the Clerk are hereby directed to execute all documents necessary on behalf of The Corporation of Haldimand County and to affix the corporate seal thereto.

READ a first and second time this 10<sup>th</sup> day of February, 2020.

READ a third time and finally passed this 10<sup>th</sup> day of February, 2020.
