

## THE CORPORATION OF HALDIMAND COUNTY

### Being a by-law to amend By-law 307/02 to regulate parking in Haldimand County - Caledonia

**WHEREAS** Section 10 of *the Municipal Act, 2001* S. O. 2001 c. 25 as amended (the Act) provides that a single-tier municipality may pass by-laws respecting any services or thing that the municipality considers necessary or desirable for the public;

**WHEREAS** in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 307/02 to regulate and govern traffic and the parking of vehicles on private or municipal property in Haldimand County;

**AND WHEREAS** the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 307/02 with respect to parking regulation in Caledonia,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** Schedule "C" No Parking – Caledonia of By-law 307/02 be amended by adding the following:
