# E. DELEGATIONS AND PRESENTATIONS

1 Crime Stoppers of Haldimand & Norfolk Re: Update on 2019 Initiatives and Funding Request for 2020 Fentanyl Initiative

Mr. Unwin & Ms. Bernardo provided the Board with an overview of 2019 events and initiatives, noting receipt of five awards of excellence and an increase in new reports for anonymous tips. Mr. Unwin & Ms. Bernardo added that they will be continuing the fentanyl initiative this March 1 to May 1 and are requesting a \$5,000 donation from the Board. It was noted that Norfolk County donated \$2,000 to this year's initiative. Discussion ensued regarding fentanyl use, deaths and community safety. Crime Stoppers was encouraged to attend an upcoming Council in Committee meeting to request additional funds from Council.

Member K. Boon moved a motion for the Board to donate \$2,000 to the 2020 fentanyl initiative to match Norfolk County. Since there was no seconder, the following motion was presented.

It was noted that the detachment currently has approximately 63% officer availability. There are ten vacancies and five officers on leave.

3 Outreach Community Policing Statistics

Inspector Carter reviewed these statistics with the Board, noting a decrease in violent crime and drug crime, and an increase in property crime in the Dunnville area. It was added that there has been an increase in crime in the Hagersville area. This information will be posted to the website.

#### 4 Monthly Report from the Detachment Commander

Inspector Carter reviewed the January monthly reports with the Board, noting a decrease in record checks, violent crime, property crime, collisions, and an increase in fraud, calls for service related to mental health and false alarms. Community Policing Committee and Crime Stopper's event were highlighted. Discussion ensued regarding human trafficking, fingerprinting, new screening process for 911 calls, and search efforts for the nine year old boy in Lake Erie.
