By-law Number /20

Being a by-law to amend By-law 302/02 to regulate parking within Haldimand County – Caledonia, in respect to snow clearing

WHEREAS Section 10 of the *Municipal Act, 2001* S. O. 2001 c. 25, as amended ("the Act") provides that at single-tier municipality may pass by-laws respecting any services or thing that the municipality considers necessary or desirable for the public;

WHEREAS in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 302/02 to regulate parking of vehicles on private or municipal property within Haldimand County in respect to snow clearing;

AND WHEREAS the Council of the Corporation of Haldimand County now deems it expedient to amend Schedule "A" of By-law 302/02 with respect to Snow Routes, and Schedule "C" of By-law 302/02 with respect to Specific Exemptions - Caledonia,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule "A" Snow Route – Caledonia of By-law 302/02 be amended by adding the following:
