Report ENG-10-2020 Parking Control Bylaw Amendment - MacNeil Court, Hagersville

### **OBJECTIVE:**

To amend Haldimand County Parking Control By-law 307/02 to create a No Parking zone in front of the Canada Post community mailbox on MacNeil Court in Hagersville.

### **EXECUTIVE SUMMARY:**

In response to concerns raised by the local Councillor, staff have reviewed the location of the new Canada Post community mailbox on MacNeil Court in Hagersville and are recommending that a No Parking zone be created to ensure that the community mail box is always accessible. This is consistent with the No Parking zone created for the original Canada Post community mailbox installed on MacNeil Court.

### **BACKGROUND:**

Parking is currently permitted on both sides of MacNeil Court with the exception of the No Parking zone in front of the Canada Post community mailbox located south of Emily Street. Since this community mailbox was installed the remaining lots on MacNeil Court have been built out and an additional Canada Post box has been installed.

Based on discussions with the local Councillor, residents are concerned with vehicles parked in front of the community mailbox limiting access and are requesting a No Parking zone at the new Canada Post Box.

## ANALYSIS:

Staff have reviewed the existing conditions and are recommending the creation of a No Parking zone in front of the new Canada Post community mailbox. Staff have also reviewed the on street parking for MacNeil Court and the proposed parking restriction will have limited impact on the available spaces. The proposed No Parking zone is shown in Attachment 1.

In order to create the No Parking area the following change to the Haldimand County Parking Control By-law 307/02 is required:
