#### G. REPORTS

#### 1 Monthly Report from the Detachment Commander

Inspector Carter reviewed the October monthly reports with the Board, noting an increase in violent crime (sexual assaults, domestic-related), and clearance rates and a decrease in property crime and collisions. It was noted that the monthly statistics include McKenzie Meadows incidents (i.e.: arson, theft, mischief, etc.). Concern was expressed regarding the increased impaired driving in the community. The activities of the Mobile Crisis Response Unit and Crime Stoppers of Haldimand and Norfolk were highlighted. Discussion ensued regarding arrests, domestic-related calls, collisions and the process for officer training. An update was also provided on internal and public complaints.

The increase in traffic, blockades and detour routes within the Caledonia town limits was noted. Inspector Carter provided an analysis of the collision data, noting that there has been an increase in collisions on these detour routes since 2019. Discussion ensued regarding the McKenzie Meadows occupation and individuals still on site despite the court order.

An update was provided on officer availability. It was noted that there are currently 63 officers available and three experienced officers will be coming to the detachment in December. It was added that the detachment also has access to additional officers in Caledonia.

A follow up was provided on the recent complaints of drug sales in Dunnville. Through an analysis of the statistics provided per location, the communities are overall safe and there has been no increase of crime in Dunnville.
