H. REPORTS

- 1 Monthly Report from the Detachment Commander

Inspector Carter reviewed the December, 2020 and January, 2021 monthly reports with the Board, noting a decrease in property crime and traffic collisions and a slight increase in violent crime. It was added that it is difficult to qualify the 2020 statistics due to the unusual circumstances related to the pandemic and McKenzie Meadows occupation. Discussion ensued regarding sexual assaults, human trafficking, the ongoing efforts of the community street crime unit, new calls for service process, and the benefits of photo radar and red light cameras in community safety zones. Inspector Carter requested that their Crime Analyst attend the March meeting to provide an overview on how the O.P.P. use analytics to reduce crime and collisions and develop strategic patrols.

The Board was advised that there is currently only one vacancy in the local detachment. A province-wide policy for new recruits was developed which prevents transfers between detachments for a two-year period. Staffing levels should remain stable for the foreseeable future.

An update was provided related to the McKenzie Meadows occupation. Roads have been re-opened and the finalization of charges is ongoing as courts have been delayed due to the pandemic.
