D. APPROVAL OF PREVIOUS MEETING MINUTES

1 Minutes from the regular meeting of February 24, 2021

E. DELEGATIONS AND PRESENTATIONS

Neil Unwin, Board Chair, Crime Stoppers of Haldimand & Norfolk Re: 2020 Annual Review and Funding Request for 2021 Initiatives

Aimee Bernardo was also in attendance. Mr. Unwin provided an overview of their 2020 awards, activities, and programs. He noted that a number of events have been cancelled due to the pandemic which has resulted in a reduction in funding. Virtual events have been scheduled for 2021 and the fentanyl initiative will be continued. It was added that a memoriam will also be sponsored for Calgary police officer, Sergeant Andrew Harnett, who was killed in the line of duty. Crime Stoppers are requesting a \$5,000 donation from the Board.

The Board commended Crime Stoppers for their work within the County.

Philip Kuckyt, Manager of Transportation Services, Student Transportation Services Brant Haldimand Norfolk Re: BusPatrol Safety Program

Mr. Kuckyt advised that this program provides additional safety features to buses in our region. He introduced Roberto Reno from BusPatrol who participated virtually.

Mr. Reno provided an overview on BusPatrol and the program, noting that the arm cameras are linked to the side of each bus and the network is managed by Al technology. The company works in collaboration with communities, schools, O.P.P., and municipalities to collect data and provide information to law enforcement officers. This program also encourages behaviour modification in both drivers and students on the bus.

Mr. Kuckyt spoke to local statistics in the area and revenues. It was noted that similar presentations were made to the Norfolk County PSB and Brant County PSB.

The Board and O.P.P. were in support of the program, noting that anything to lever technology and enhance the safety of our children is key.

Discussion ensued regarding the framework for the new detachment Board, noting that 20% must be provincial appointments. Concerns were expressed regarding the current provincial appointment vacancies. The municipality is required to determine the composition of their board and submit their proposal to the ministry by June 7th.
