We are writing to ask for permission to remove and replace the windows at our home which have been designated historical.

During the terrible wind storm of November 2020, we lost 3 large trees on the property, one which broke our dining room window and did damage to others. Most of the windows in the home are either cracked or have rot issues and are at the point where interior damage is imminent. We are planning on replacing them with the utmost integrity as the house demands. They will look as close to original as possible. We are willing to store the original ones in the basement so that if at some point in time another owner has the considerable resources to restore them to their former glory, this would be possible. This however would be cost prohibitive to us.

We are asking Council's permission to begin this process. We have already spoken with the Historical Society of Haldimand and have their approval.
