By-law Number /21

Being a by-law to amend By-law 1942/18, the Rate of Speed By-law, re: Sweets Corner Road, Kohler Road and South Cayuga Road

WHEREAS Section 27(1) of the *Municipal Act, 2001*, S.O. 2001, c. 25., as amended, (Act) authorizes municipalities to pass by-laws in respect of a highway under its jurisdiction;

WHEREAS in accordance with the Act, the Council of the Corporation of Haldimand County enacted By-law 1942/18 to regulate different rates of speed for motor vehicles driven on a highway or a portion of a highway in Haldimand County;

AND WHEREAS the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 1942/18 with respect to the maximum rates of speed on Sweets Corner Road, Kohler Road and South Cayuga Road,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule "A" of By-law 1942/18 be amended by deleting the following sections:

Sweets Corner Road	Lakeshore Road	Bains Road	80 km/h
Kohler Road	Lakeshore Road	650 metres South of Link Road	80 km/h
South Cayuga Road	Lakeshore Rd	Bains Road	50 km/h

2. **THAT** Schedule "A" of By-law 1942/18 be amended by adding the following sections.

Sweets Corners Road	Bains Road	200 metres North of Rainham Road	80 km/h
Sweets Corners Road	200 metres North of Rainham Road	720 metres South of Rainham Road	60 km/h
Sweets Corners Road	720 metres South of Rainham Road	Lakeshore Road	80 km/h
Kohler Road	650 metres South of Link Road	160 metres North of Rainham Road	80 km/h
Kohler Road	160 metres North of Rainham Road	390 meters South of Rainham Road	60 km/h
Kohler Road	390 metres South of Rainham Road	Lakeshore Road	80 km/h
South Cayuga Road	Lakeshore Road	440 metres North of Rainham Road	50 km/h
South Cayuga Road	440 metres North of Rainham Road	Bains Road	80 km/h

- 3. **THAT** this by-law shall take precedence over any other by-law with which is inconsistent.
- 4. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision has been installed and is on display.
