Report ECW-11-2021 Bramble Crescent, Townsend – Alternate Side Parking - By-law Amendment



For Consideration by Council in Committee on November 16, 2021

OBJECTIVE:

To receive Council approval to amend Haldimand County Winter Control By-law 302/02 and Parking Control By-law 307/02 to modify the parking regulations on Bramble Crescent in Townsend.

EXECUTIVE SUMMARY:

Residents on Bramble Crescent were recently notified by Student Transportation Services of Brant Haldimand Norfolk (STSBHN) that as of October 21, 2021 their bus stop would be moved to the corner of Nanticoke Creek Parkway and Willow Glen Road because Bramble Crescent is too narrow to navigate due to the cars parked along both sides of the street.

STSBHN has confirmed that if parking is limited to one side of Bramble Crescent the bus service will be resumed. Staff are recommending that this change be implemented to restore the bus route.

BACKGROUND:

As shown in the attached aerial photo (see Attachment 1) Bramble Crescent is an L-shaped street looping around from Willow Glen Drive to Woodfield Avenue with parking permitted on both sides of the street from April 15th to November 15th changing to alternate side parking during the winter months.

Residents on Bramble Crescent were recently notified by Student Transportation Services of Brant Haldimand Norfolk (STSBHN), which coordinates busing for students attending the Grand Erie District School Board, that as of October 21, 2021 their bus stop would be moved to the corner of Nanticoke Creek Parkway and Willow Glen Road because Bramble Crescent is too narrow to navigate due to the cars parked along both sides of the street.

Based on information provided to the local councillor a number of families on Bramble Crescent have children that are picked up by the busing service and are concerned about the new bus stop because of its location on Nanticoke Creek Parkway, which is a relatively busy road.

STSBHN has confirmed that if parking is limited to one side of Bramble Crescent that the bus service on the street will be resumed.

ANALYSIS:

Based on a review of the existing conditions it is anticipated that the proposed change to alternate side parking will have a minimal effect on the residents as there is sufficient parking both in driveways as well as on the street. As noted above the school busing service will be resumed if the switch to alternate side parking is made.

The local councillor has discussed the proposed change to alternate side parking with the residents on Bramble Crescent and given the reason for the change there is general support to implement year round alternate side parking.

In order to permit alternate side parking on Bramble Crescent the following amendments to Parking Control By-law 307/02 are required:

In order to establish year round alternate side parking on Bramble Crescent the following amendment to Winter Control Parking By-law 302/02 is required:
