- AND THAT the General Manager, Corporate & Social Services have delegated authority to renew the policies in the first quarter of 2022, based upon the final premiums provided by Marsh Canada Limited and Arthur J. Gallagher Canada Limited to an upset limit of \$810,000 inclusive of applicable taxes, approximately a 25% increase over the 2021 insurance premiums;
