A. CALL TO ORDER

Deputy Mayor Corbett called the Council in Committee meeting to order at 9:30 a.m.

D. PUBLIC MEETING FOR PLANNING APPLICATIONS

Councillor Patterson, Chair of Public Meeting for Planning Applications, assumed the Chair for this portion of the meeting.

Prior to commencing the public meeting, the Chair explained the meeting, delegation and appeal process. He noted that decisions made by Committee at this meeting would be given final consideration at the February 14, 2022 Council meeting.

 - A. Taylor presented the report.

Stephen Armstrong, Armstrong Planning & Project Management, spoke to the application and the related Official Plan Review through the province. He also spoke to the related community benefit, specifically the parks, trails and a pumping station to be built.

Neal DeRuyter, MHBC Planning, Urban Design & Landscape Architecture spoke to a concern that the setback limit comes from the extraction limit and that a holding provision will remove public access to the process. Lafarge is requesting that the draft plan subdivision approval should be undelegated.

C. Siemiginowski, Land Manager, Lafarge spoke to the concern about the use of a historic blasting limit that, in their opinion, is inappropriate in this case, and should be 300 m. from the extraction limit. They find that the technical studies submitted are inadequate and require Lafarge to make adjustments. They are

requesting a deferral on the decision in order to refine the setback requirement and complete a peer review of technical studies.

Margaret Young lives nearby and spoke to long-standing residents becoming used to blasting where newer residents may notice it more.
