EXECUTIVE SUMMARY:

Report CDS-01-2022 has been prepared to update Council on the 2021 initiatives, activities and statistics that have taken place within the Community and Development Services Department throughout the year, as it relates to development and vibrancy matters.

BACKGROUND:

As part of ongoing efforts to be able to communicate the activities, initiatives and impact of the Department's programs to Council and ratepayers, in late 2011 annual performance measures were developed, and in January 2012 a quarterly 'activity' report and an annual report on performance was developed to provide interim updates. Since 2019, the Community and Development Services Department has shifted to provision of an annual report and presentation to provide a summary of activities. That summary is included as Attachment 1.

ANALYSIS:

Key Highlights for 2021:

While much of the world slowed down in 2021, the Department had one of its busiest and most challenging years ever. Despite the increases in work volume and the continued obstacles the pandemic posed to service delivery, the Department enjoyed an immense amount of accomplishment and success. The full details of that work output and the associated community benefit is expressed in Attachment 1, but included below is a sampling of the transformative work that was completed in the year gone by:

- **Digital Service Squad**: staff worked to secure over \$102,500 in grants for 41 businesses which will assist them in their transformation to (more) digital marketing and promotion.
- Farm 911 Emily Project: development and launch of address signage program which assists first responders in property identification and access. Staff secured multiple private sponsorships to cover the costs of 35 signs in 2021 and up to 55 signs for 2022. A total of 31 signs were issued in 2021 one of the highest program uptakes in the Province.
- **Patio Program**: staff worked across various divisions to issue 21 permits resulting in a new inventory of 686 outdoor seats (on private and public lands) that supported the hospitality industry in the County.
- **PATH and GeoTour**: planning, marketing and launch of two new and very successful recreation programs that showcased local art (PATH) and many of the great spaces/places the County has to offer (GeoTour). The County's GeoTour was the 2nd highest rated geocache activity in the Province.
- Youth & Seniors Advisory Committees: completed all promotion, recruitment and work planning for these two very important advisory committees of Council.
- **County Official Plan Phase 1**: Council adoption and Provincial approval of Phase 1 of the County's Official Plan Update, including a 30 year growth strategy to guide land use decisions, infrastructure planning and community facility planning.
- **Development approvals**: completed review of over 220 planning applications (a 5 year high) resulting in approvals for over 1,400 new housing units and over 27,000 sq. m. (291,000 sq. ft.) of new commercial/industrial space.
- CityView Portal: final testing, staff training and 'soft launch' of CityView Portal, a full e-permitting
 process which includes electronic application submission, electronic plan review, on-line
 payment and electronic permit issuance.
- Building permits: issuance of over 1,780 building permits, a new Haldimand County record.
- **Palliative Care Program**: all County Paramedics completed requisite training and the program officially launched which will see medics respond to palliative patients within the community. This program will assist in treating patients at home and prevent ER visits.
- **Community Paramedic Program:** additional funding secured and program expanded to include more resources for High Intensity Patients. Client list is now over 160 persons and climbing.
- **Cayuga arena mass vaccination clinic (MVC)**: Planning and supports for the MVC, including design and set up. Paramedics participated in vaccinating and monitoring of patients on-site, in LTC facilities and in the homes of vulnerable populations. Firefighters were onsite at the clinics to provide traffic control, and front entrance security to ensure an organized flow of patients to receive vaccinations.
