1 Monthly Report from the Detachment Commander

Inspector Carter reviewed the November to December, 2021 monthly reports with the Board, noting an overall year-to-date decrease in violent crime, property crime, collisions, calls for service, and an increase in traffic stops. Public complaints, the speed spy deployment program, and the efforts of the Auxiliary Unit, Crime Stoppers of Haldimand and Norfolk and the Community Street Crime Unit were also highlighted.

In January and February, 2022, a decrease in violent crime, property crime, calls for service, and an increase in collisions and community engagement was noted. Complaints, e-ticketing and the body camera program was also highlighted.

Discussion ensued regarding speed control, calls for service, neighbour and domestic disputes, patrols in Port Maitland, and police visibility.

2 Update Re: Board's February 8, 2022 Delegation to Haldimand County Council B. Haggith provided an update on the Board's delegation, noting that it was well-received by Haldimand County Council. A motion was passed to lobby the provincial government to review OPP policy document "A Framework for Police Preparedness for Indigenous Critical Incidents" (OPP Framework) and to change the policing model in Ontario from a "Police Independent Model" to a "Democratic Policing Model".

The Board has also requested to speak at a future OAPSB meeting.

#### 3 OPP Overtime Hours

Inspector Carter spoke to the integrated nature of the policing contract, noting that it is very convoluted. There was a period of time where the detachment went through a staffing shortage. The overtime hours related to the court process is also difficult to manage. It was noted that the Municipal Policing Bureau 2020 actuals will be released this fall.

#### 4 Mobile Crisis Response Team Funding

The detachment was denied the additional grant funding for this program which would have been used to expand the operational hours. It was clarified that this funding would have been in addition to the current service provided.

## 5 Update Re: Criminal Record Checks

Currently, it is mandated that there is no charge for volunteer applications. It was noted that there is a six week wait for volunteers and three to four weeks for employment applications. The Board was advised that criminal record checks will be going back to a centralized process where applications can be submitted online at any time.

## 6 Update Re: Ontario Good Roads Association (OGRA) 2022 Conference

B. Corbett and D. Lawrence provided an overview of their discussion with representatives from the Ministry of the Solicitor General's office at the recent OGRA conference. A meeting will be scheduled with a senior member of the OPP to outline the concerns of the Board.

#### 7 Inquiry Re: Unregulated Short-Term Vacation Rentals

Discussion ensued regarding Airbnb rentals in the County and concerns related to potential noise complaints.

#### 8 Fraud Awareness

Discussion ensued around fraud and scams and the susceptibility to vulnerable people in the community. The OPP continues to send out media releases to increase public awareness on the issue.
