- 2. **AND THAT** this by-law shall take force in accordance with the provisions of the Planning Act.



Amendment No. HCOP-67 to the Haldimand County Official Plan

Part A: Preamble to the Amendment

1. Purpose of the Amendment

The purpose of this Official Plan Amendment is to amend the designation of the subject lands by adding a special policy to the 'Agricultural' designation to permit a concrete plant.

2. Location of the Lands Affected

The subject lands are described as Oneida, Range West of Plank Road, Part Lot 16, Haldimand County, municipally know as 28 3rd Line. The location of the subject lands is illustrated on the attached Map "A".

3. Basis of the Amendment

This amendment is consistent with the Provincial Policy Statement, 2020 and A Place to Grow: Growth Plan for the Greater Golden Horseshoe, 2020.

Part B: The Amendment

The Haldimand County Official Plan is hereby amended as follows:

Map Schedule Amendment

Schedule A.1 is hereby further amended by:

Identifying the lands shown as the subject lands on Map "A" of this amendment (attached to and forming part of this amendment) as being amended to a site-specific 'Agricultural' designation (HCOP-67).

Text Amendment

That the following policy be added to Section 9.D. Site-Specific Policies (Haldimand County):

HCOP-67 In addition to the Agricultural uses permitted on these lands, a concrete plant shall also be permitted on the subject lands identified on Schedule 'A' of this site specific amendment and as shown generally on Schedule A.1 of this Plan. Severance of the subject lands shall also be permitted.

Part C: Additional Information

Implementation

This amendment will be implemented by Haldimand County by enacting an amendment to the Haldimand County Zoning By-law HC 1-2020.
