By-law Number -HC/22

Being a by-law to amend Zoning By-law HC 1-2020, as amended, for property described in the name of Haldimand War Memorial Hospital – ‘Holding – “H”’ provision removal

WHEREAS Haldimand County is authorized to enact this by-law, by virtue of the provisions of Section 34 and 36(1) of the *Planning Act*, R.S.O. 1990, CHAPTER P.13, as amended;

AND WHEREAS this by-law conforms to the Haldimand County Official Plan,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** this by-law shall apply to lands described as PLAN 396 PT LOT K PT LOT L and shown on Maps “A” and “B” attached to and forming part of this by-law.
2. **THAT** Schedule “A” of By-law HC 1-2020, as amended, is hereby further amended by removing the ‘Holding “H”’ provision from the subject lands shown on Maps “A” and “B” (attached to and forming part of this by-law) at such time as the General Manager of Community & Development Services is satisfied that all conditions relating to the ‘Holding – “H”’ provision have been met and the said General Manager issues a memo to the same effect.
3. **AND THAT** this by-law shall shall come into force in accordance with the provisions of the *Planning Act*.

READ a first and second time this 26th day of September, 2022.

READ a third time and finally passed this 26th day of September, 2022.

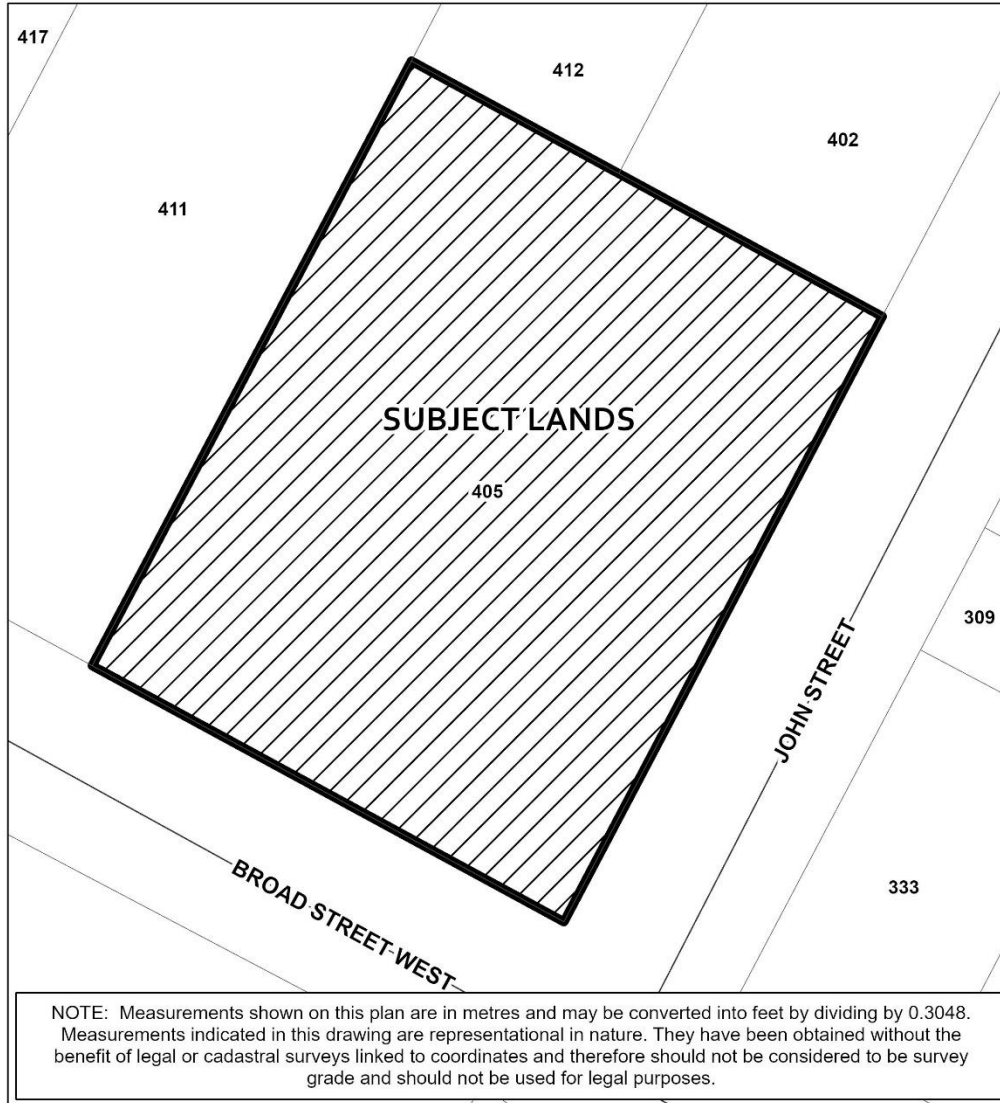
MAP B - Detail Map

PURPOSE AND EFFECT OF BY-LAW /22

The subject lands are legally described as PLAN 396 PT LOT K PT LOT L and municipally addressed as 405 Broad Street West, Dunnville.

The purpose of this by-law is to grant the General Manager of Community & Development Services the authority to remove the Holding (H) provision from the subject lands upon a site plan agreement being registered on title, which commits the parking on the subject lands to Edgewater Gardens and the HWMH; a Site Plan application being approved by the General Manager of Community & Development Services; and archaeological investigation and approval to the satisfaction of Haldimand County.

The H provision removal must be approved by the General Manager of Community & Development Services and the said General Manager must issue a memo to that effect prior to development.
