Being a by-law to amend By-law 307/02 being a by-law to regulate parking in Haldimand County - Jarvis and Caledonia

WHEREAS Section 10 of the *Municipal Act, 2001* S. O. 2001 c. 25, as amended (Act) provides that a single-tier municipality may pass by-laws respecting any services or things that the municipality considers necessary or desirable for the public;

WHEREAS in accordance with the Act, the Council of the Corporation of Haldimand County enacted the By-law 307/02 to regulate and govern traffic and the parking of vehicles on private or municipal property in Haldimand County;

AND WHEREAS the Council of the Corporation of Haldimand County now deems it expedient to amend By-law 307/02 with respect to Schedule "C" No Parking, Schedule "D" Restricted Parking and Schedule "I" Angle Parking of said by-law,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule "I" – Angle Parking –Jarvis of By-law 307/02`be amended by adding the following:

2. **THAT** Schedule "D" – Restricted Parking - Jarvis of By-law 307/02 be amended by adding the following:

Park Street	East	10 metres South of Talbot Street East – two designated spaces	8 a.m. to 2 a.m.	2 hours

3. **THAT** Schedule "C" – No Parking – Caledonia of By-law 307/02 be amended by deleting the following:

East Edinburgh Square Road	East	North limit of Caithness Street East	South limit of Sutherland Street East	Anytime
East Edinburgh Square Road	West	North limit of Caithness Street East	A point 42 metres north of Caithness Street East	Anytime

And replacing it with the following:

STREET	SIDE	FROM	то	PERIOD
East Edinburgh Square Road	East	North limit of Caithness Street East	A point 42 metres north of Caithness Street East	Anytime
East Edinburgh Square Road	West	North limit of Caithness Street East	South limit of Sutherland Street East	Anytime

- 4. **THAT** this by-law shall take precedence over any by-law with which is inconsistent.
- 5. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision had been installed and is on display.
