## THE CORPORATION OF HALDIMAND COUNTY

By-law Number /22

Being a by-law to levy the actual cost of maintenance of the McNichol, Sweets Corners, Ordnance Reserve, Black Creek, Sixth Concession, Maple Creek Dunn Branch, Bravin, Deamude, West Kelly, Byers, Boulton, Ellsworth, Furry, Crow Road, East Kelly, Chalmers Dickout, H.E. Dickout, Bouck and Moyer, Brown, Boorsma, Charles Angle, Dent, Hartnett Branch #1, Hartnett Branch #2, Hartnett Main. Chick Main, North Hutchinson North, Hutchinson South, South Hutchinson, Little Marsh, and Vaughan municipal drains on the assessed lands

**WHEREAS** Section 61 of the *Drainage Act*, R.S.O. 1990, c.D17 (Act) provides that the council of the local municipality that is required to raise the cost of drainage works shall by by-law impose the costs upon the assessed land, payable in such installments as the council may prescribe;

**WHEREAS** Section 74 of the Act requires that the local municipality raise the cost of maintenance of drainage work at the expense of all upstream lands and roads in any way assessed for the construction or improvement of the drainage works;

**WHEREAS** the McNichol Municipal Drain was maintained by Haldimand County at a total project cost of \$58,017.91 and now requires the remaining costs, after any applicable grants/allowances, of \$48,280.09 to be recovered from the lands benefiting from said work;

**WHEREAS** the Sweets Corners Municipal Drain was maintained by Haldimand County at a total project cost of \$641.09 and now requires the remaining costs, after any applicable grants/allowances, of \$641.09 to be recovered from the lands benefiting from said work;

**WHEREAS** the Ordnance Reserve Municipal Drain was maintained by Haldimand County at a total project cost of \$794.63 and now requires the remaining costs, after any applicable grants/allowances, of \$756.81 to be recovered from the lands benefiting from said work;

**WHEREAS** the Black Creek Municipal Drain was maintained by Haldimand County at a total project cost of \$9,972.48 and now requires the remaining costs, after any applicable grants/allowances, of \$7,911.40 to be recovered from the lands benefiting from said work;

**WHEREAS** the Sixth Concession Municipal Drain was maintained by Haldimand County at a total project cost of \$3,764.35 and now requires the remaining costs, after any applicable grants/allowances, of \$407.14 to be recovered from the lands benefiting from said work;

**WHEREAS** the Maple Creek Dunn Branch Municipal Drain was maintained by Haldimand County at a total project cost of \$19,900.55 and now requires the remaining costs, after

any applicable grants/allowances, of \$19,900.55 to be recovered from the lands benefiting from said work;

**WHEREAS** the Bravin Municipal Drain was maintained by Haldimand County at a total project cost of \$71,017.86 and now requires the remaining costs, after any applicable grants/allowances, of \$54,113.80 to be recovered from the lands benefiting from said work:

**WHEREAS** the Deamude Municipal Drain was maintained by Haldimand County at a total project cost of \$1,613.91 and now requires the remaining costs, after any applicable grants/allowances, of \$1,334.97 to be recovered from the lands benefiting from said work;

**WHEREAS** the West Kelly Municipal Drain was maintained by Haldimand County at a total project cost of \$67,076.93 and now requires the remaining costs, after any applicable grants/allowances, of \$50,132.51 to be recovered from the lands benefiting from said work;

WHEREAS the Byers Municipal Drain was maintained by Haldimand County at a total project cost of \$84.35 and now requires the remaining costs, after any applicable grants/allowances, of \$84.35 to be recovered from the lands benefiting from said work;

**WHEREAS** the Boulton Municipal Drain was maintained by Haldimand County at a total project cost of \$25,299.32 and now requires the remaining costs, after any applicable grants/allowances, of \$20,781.51 to be recovered from the lands benefiting from said work;

**WHEREAS** the Ellsworth Municipal Drain was maintained by Haldimand County at a total project cost of \$352.92 and now requires the remaining costs, after any applicable grants/allowances, of \$352.92 to be recovered from the lands benefiting from said work;

**WHEREAS** the Furry Municipal Drain was maintained by Haldimand County at a total project cost of \$50,981.58 and now requires the remaining costs, after any applicable grants/allowances, of \$39,685.67 to be recovered from the lands benefiting from said work;

**WHEREAS** the Crow Road Municipal Drain was maintained by Haldimand County at a total project cost of \$1,566.09 and now requires the remaining costs, after any applicable grants/allowances, of \$1,309.20 to be recovered from the lands benefiting from said work;

**WHEREAS** the East Kelly Municipal Drain was maintained by Haldimand County at a total project cost of \$2,766.72 and now requires the remaining costs, after any applicable grants/allowances, of \$2,244.29 to be recovered from the lands benefiting from said work;

**WHEREAS** the Chalmers Dickout Municipal Drain was maintained by Haldimand County at a total project cost of \$15,869.48 and now requires the remaining costs, after any applicable grants/allowances, of \$13,620.12 to be recovered from the lands benefiting from said work;

**WHEREAS** the H.E. Dickout Municipal Drain was maintained by Haldimand County at a total project cost of \$42,446.55 and now requires the remaining costs, after any applicable grants/allowances, of \$34,625.72 to be recovered from the lands benefiting from said work;

**WHEREAS** the Bouck and Moyer Municipal Drain was maintained by Haldimand County at a total project cost of \$58,268.71 and now requires the remaining costs, after any applicable grants/allowances, of \$45,167.67 to be recovered from the lands benefiting from said work;

**WHEREAS** the Brown Municipal Drain was maintained by Haldimand County at a total project cost of \$7,334.05 and now requires the remaining costs, after any applicable grants/allowances, of \$5,853.78 to be recovered from the lands benefiting from said work;

**WHEREAS** the Boorsma Municipal Drain was maintained by Haldimand County at a total project cost of \$19,181.36 and now requires the remaining costs, after any applicable grants/allowances, of \$13,285.59 to be recovered from the lands benefiting from said work;

**WHEREAS** the Charles Angle Municipal Drain was maintained by Haldimand County at a total project cost of \$3,214.80 and now requires the remaining costs, after any applicable grants/allowances, of \$3,068.22 to be recovered from the lands benefiting from said work;

**WHEREAS** the Dent Municipal Drain was maintained by Haldimand County at a total project cost of \$26,907.44 and now requires the remaining costs, after any applicable grants/allowances, of \$20,718.60 to be recovered from the lands benefiting from said work;

**WHEREAS** the Hartnett Branch #1 Municipal Drain was maintained by Haldimand County at a total project cost of \$1,891.06 and now requires the remaining costs, after any applicable grants/allowances, of \$1,296.95 to be recovered from the lands benefiting from said work;

**WHEREAS** the Hartnett Branch #2 Municipal Drain was maintained by Haldimand County at a total project cost of \$1,027.56 and now requires the remaining costs, after any applicable grants/allowances, of \$724.84 to be recovered from the lands benefiting from said work;

**WHEREAS** the Hartnett Main Municipal Drain was maintained by Haldimand County at a total project cost of \$8,874.51 and now requires the remaining costs, after any applicable grants/allowances, of \$6,307.33 to be recovered from the lands benefiting from said work;

**WHEREAS** the Chick Main Municipal Drain was maintained by Haldimand County at a total project cost of \$7,091.93 and now requires the remaining costs, after any applicable grants/allowances, of \$4,806.55 to be recovered from the lands benefiting from said work;

**WHEREAS** the North Hutchinson North Municipal Drain was maintained by Haldimand County at a total project cost of \$18,387.81 and now requires the remaining costs, after any applicable grants/allowances, of \$14,838.80 to be recovered from the lands benefiting from said work;

**WHEREAS** the North Hutchinson South Municipal Drain was maintained by Haldimand County at a total project cost of \$13,783.14 and now requires the remaining costs, after any applicable grants/allowances, of \$12,491.92 to be recovered from the lands benefiting from said work;

**WHEREAS** the South Hutchinson Municipal Drain was maintained by Haldimand County at a total project cost of \$17,358.57 and now requires the remaining costs, after any applicable grants/allowances, of \$13,509.73 to be recovered from the lands benefiting from said work;

**WHEREAS** the Little Marsh Municipal Drain was maintained by Haldimand County at a total project cost of \$10,003.01 and now requires the remaining costs, after any applicable grants/allowances, of \$8,428.75 to be recovered from the lands benefiting from said work;

**AND WHEREAS** the Vaughan Municipal Drain was maintained by Haldimand County at a total project cost of \$6,554.54 and now requires the remaining costs, after any applicable grants/allowances, of \$3,866.10 to be recovered from the lands benefiting from said work,

## NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

- 1. **THAT** The Treasurer shall levy the amount of \$48,280.09 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "1", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the McNichol Drain.
- 2. **THAT** The Treasurer shall levy the amount of \$641.09 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "2", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sweets Corners Drain.
- 3. **THAT** The Treasurer shall levy the amount of \$756.81 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "3", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Ordnance Reserve Drain.
- 4. **THAT** The Treasurer shall levy the amount of \$7,911.40 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "4", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Black Creek Drain.
- 5. **THAT** The Treasurer shall levy the amount of \$407.14 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "5", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Sixth Concession Drain.
- 6. **THAT** The Treasurer shall levy the amount of \$19,900.55 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "6", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Maple Creek Dunn Branch Drain.

- 7. **THAT** The Treasurer shall levy the amount of \$54,113.80 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "7", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Bravin Drain.
- 8. **THAT** The Treasurer shall levy the amount of \$1,334.97 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "8", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Deamude Drain.
- 9. **THAT** The Treasurer shall levy the amount of \$50,132.51 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "9", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the West Kelly Drain.
- 10. **THAT** The Treasurer shall levy the amount of \$84.35 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "10", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Byers Drain.
- 11. **THAT** The Treasurer shall levy the amount of \$20,781.51 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "11", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Boulton Drain.
- 12. **THAT** The Treasurer shall levy the amount of \$352.92 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "12", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Ellsworth Drain.
- 13. **THAT** The Treasurer shall levy the amount of \$39,685.67 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "13", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Furry Drain.
- 14. **THAT** The Treasurer shall levy the amount of \$1,309.20 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "14", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Crow Road Drain
- 15. **THAT** The Treasurer shall levy the amount of \$2,244.29 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "15", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the East Kelly Drain.
- 16. **THAT** The Treasurer shall levy the amount of \$13,620.12 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "16", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Chalmers Dickout Drain.
- 17. **THAT** The Treasurer shall levy the amount of \$34,625.72 against the lands and roads in the municipality in accordance with the amended assessment schedule

as set out in Schedule "17", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the H.E. Dickout Drain.

- 18. **THAT** The Treasurer shall levy the amount of \$45,167.67 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "18", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Bouck and Moyer Drain.
- 19. **THAT** The Treasurer shall levy the amount of \$5,853.78 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "19", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Brown Drain.
- 20. **THAT** The Treasurer shall levy the amount of \$13,285.59 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "20", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Boorsma Drain.
- 21. **THAT** The Treasurer shall levy the amount of \$3,068.22 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "21", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Charles Angle Drain.
- 22. **THAT** The Treasurer shall levy the amount of \$20,718.60 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "22", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Dent Drain.
- 23. **THAT** The Treasurer shall levy the amount of \$1,296.95 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "23", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Hartnett Branch #1 Drain.
- 24. **THAT** The Treasurer shall levy the amount of \$724.84 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "24", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Hartnett Branch #2 Drain.
- 25. **THAT** The Treasurer shall levy the amount of \$6,307.33 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "25", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Hartnett Main Drain.
- 26. **THAT** The Treasurer shall levy the amount of \$4,806.55 against the lands and roads in the municipality in accordance with the amended assessment schedule

- as set out in Schedule "26", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Chick Main Drain.
- 27. **THAT** The Treasurer shall levy the amount of \$14,838.80 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "27", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the North Hutchinson North Drain.
- 28. **THAT** The Treasurer shall levy the amount of \$12,491.92 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "28", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the north Hutchinson South Drain.
- 29. **THAT** The Treasurer shall levy the amount of \$13,509.73 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "29", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the South Hutchinson Drain.
- 30. **THAT** The Treasurer shall levy the amount of \$8,428.75 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "30", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Little Marsh Drain.
- 31. **THAT** The Treasurer shall levy the amount of \$3,866.10 against the lands and roads in the municipality in accordance with the amended assessment schedule as set out in Schedule "31", attached hereto, and being the amounts to be charged for completing the maintenance of drainage works known as the Vaughan Drain.
- 32. **THAT** should the assessed owners of the lands elect to pay the amounts levied over a five (5) year period, such amounts shall be assessed, levied and collected in the same manner and at the same time as other taxes of the municipality are assessed, levied and collected, upon and from such parcels of land listed in the aforementioned Schedules "1" through "31", together with interest thereon at a rate that shall be established as 6.0% per annum except where the assessment against any parcel of land is five hundred dollars (\$500.00) or less, where such assessment shall be paid in four installments over one calendar year.
- 33. **AND THAT** this by-law shall come into force and effect on the day of passing.
