#### E. NEW BUSINESS

1 Opening Remarks

C. Manley provided an overview of the development of the budget, highlighting the factors and principles included in the internal review process. Major factors that influenced the budget include external pressures like inflation, supply chain impacts, reduced/uncertain provincial funding and the rising cost of insurance and contracted essential services. The budget results in a total levy requirement of \$80,305,850, which equates to a residential tax impact of 3.28%.

The new initiatives being recommended in response to growth, new legislative requirements and to meet the community's evolving needs and service desires were also highlighted.
