

For the winter months- winter tires, preparing your vehicle, See Snow Go Slow along with ice safety.	

Public Education Campaigns	Social media is also utilized to the fullest to assist in preventing and reducing crime in our community. It also allows the OPP to engage with our community members on a regular basis and gives them a glimpse into what our officers are responding to. It also allows us to be proactive in getting the safety messaging out to Haldimand County and Mississauga of the Credit First Nations Community.
Community Street Crime Unit	The street crimes unit is comprised of members from Haldimand and Norfolk OPP. During February, the Community Street Crime Unit was involved in 10 investigations which included 5 warrants. As a result, 2 drug related charges and 3 Criminal Code charges were laid. Total value of drug seizures was \$200.00; the total value of cash seizures was \$0.00; and the total value of property seizures was \$300.00 (***Results are from CSCU weekly reports***).

Violent Crime

Violent Crime for February reported at 18. Violent Crime did see a decrease of 1 (5.9%) from February last year. A year-to-date decrease of 18.2% was observed from the same time frame last year.

Property Crime

Property Crime for February reported at 53. Property Crime did see an increase of 8 (17.8%) from February last year. A year-to-date increase of 26.3% was observed from the same time frame last year.

Notable Increases

Notable increases were observed when looking at property crime over the year to date statistics.

Break and Enters

23% of B&Es were at unoccupied cottages within a two-week time frame. Other locations may not have someone watching their property or may not report it to police. There may be more reports as people start going to their cottages.

- Two B&Es on rural farms, in which suspects broke into detached garages or barns. In both, lots of tools were stolen.

- Two occurrences were persons breaking into a tow compound and checking on a vehicle that was involved in a previous occurrence, including collision and an arson.

- Two spots that are frequently broken into were targeted. There is a common pattern of these places being broken into.

Theft Over

78% of occurrences were stolen vehicles. 80% of occurrences were related to stolen vehicles, trailers, ATVs, and so forth.

- 4 occurrences had unlocked cars with the keys in or around the vehicle (i.e. in the door of residence). There is minimal surveillance. Any surveillance is usually poor quality, therefore unable to identify suspects or provide additional information.

- One location was the target for multiple occurrences since December 2022, including break and enters, suspicious persons and mischief.

- Several occurred at isolated or rural areas, such as farms, conservation areas, or wind turbines (to steal copper).

Please note that two occurrences from each category were included under both B&E and theft over. Overall, frequently targeted locations were broken into or stolen from in February. More rural/isolated locations were targeted, resulting in little to no surveillance. Tools are commonly targeted, which may be at farms or construction sites.
