

## THE CORPORATION OF HALDIMAND COUNTY

By-law Number /23

### Being a by-law to further amend By-law 307/02, a by-law to regulate parking in Haldimand County

**WHEREAS** Section 10 of the *Municipal Act*, 2001 S. O. 2001 c. 25, as amended (Act) provides that a single-tier municipality may pass by-laws respecting any services or things that the municipality considers necessary or desirable for the public;

**WHEREAS** in accordance to the Act, the Council of the Corporation of Haldimand County enacted by-law 307/02 to regulate and govern traffic and the parking of vehicles on private or municipal property in Haldimand County;

**AND WHEREAS** the Council of the Corporation of Haldimand County now deems it expedient to further amend By-law 307/02 with respect to Schedule “B” No Stopping, Schedule “C” No Parking and Schedule “F” School Bus Loading Zone of said by-law,

**NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:**

1. **THAT** Schedule “B” – No Stopping – Caledonia of By-law 307/02 be amended by adding the following:

STREET	SIDE	FROM	TO	PERIOD
Caithness Street West	North	A point 20 metres east of Blair Street PXO Crossing	Blair Street PXO Crossing	Anytime
Caithness Street West	South	A point 15 metres west of Blair Street	10 metres east of Blair Street PXO Crossing	Anytime

2. **THAT** Schedule “B” No Stopping – Cayuga of By-law 307/02 be amended by adding the following:

STREET	SIDE	FROM	TO	PERIOD
Thorburn Street	Both	A point 15 metres north of Joseph Street PXO Crossing	A point 15 metres south of Joseph Street	Anytime

3. **THAT** Schedule “B” No Stopping – Dunnville of By-law 307/02 be amended by adding the following:

STREET	SIDE	FROM	TO	PERIOD
Main Street	Both	15 metres east of John Street PXO Crossing	15 metres west of John Street PXO Crossing	Anytime
Broad Street	Both	15 metres east of Oak Street PXO Crossing	15 metres west of Oak Street PXO Crossing	Anytime

4. **THAT** Schedule “B”- No Stopping - Hagersville of By-law 307/02 be amended by deleting the following:

Parkview Road	North	Laidlaw Street	115 metres east of Laidlaw Street	7 a.m. to 9 a.m. and 3 p.m. to 4:30 p.m. September 1 <sup>st</sup> to June 30 <sup>th</sup>

5. **THAT** Schedule “B” – No Stopping- Hagersville of By-law 307/02 be amended by adding the following:

Parkview Road	South	A point 15 metres west of Laidlaw Street PXO Crossing	10 metres east of Laidlaw Street PXO Crossing	Anytime

6. **THAT** Schedule “B” No Stopping – Jarvis of By-law 307/02 be amended by adding the following:

Main Street South	East	A point 15 metres south of Karsten Avenue PXO Crossing	A point 15 metres north of Karsten Avenue PXO Crossing	Anytime
Main Street South	West	A point 15 metres north of Karsten Avenue PXO Crossing	A point 15 metres south of Karsten Avenue PXO Crossing	Anytime

Berwick Street	Both	Forfar Street East	60 metres south	7 a.m. to 5 p.m. Monday to Friday

9. **THAT** Schedule “C” No Parking – Dunnville of By-law 307/02 be amended by deleting the following:

STREET	SIDE	FROM	TO	PERIOD
Main Street	North	Helena Street	Tamarac Street	Anytime

10. **THAT** Schedule “C” No Parking – Dunnville of By-law 307/02 be amended by adding the following:

STREET	SIDE	FROM	TO	PERIOD
Main Street	North	Helena Street	15 metres west of John Street PXO Crossing	Anytime
Main Street	North	15 metres east of John Street PXO Crossing	Tamarac Street	Anytime

11. **THAT** Schedule “C” No Parking – Jarvis – of By-law 307/02 be amended by deleting the following:

STREET	SIDE	FROM	TO	PERIOD
Main Street	West	Karsten Avenue	15 metres north	Anytime
Main Street	West	Karsten Avenue	17 metres south	Anytime

12. **THAT** Schedule “F” School Bus Loading Zone – Hagersville of By-law 307/02 be amended by deleting the following:

STREET	SIDE	FROM	TO
Parkview Road	South	22 metres east of the centreline of Laidlaw Street	69 metres east of the centreline of Laidlaw Street

13. **THAT** this by-law shall take precedence over any by-law with which is inconsistent
14. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision has been installed and is on display.

READ a first and second time this 19<sup>th</sup> day of April, 2023.

READ a third time and finally passed this 19<sup>th</sup> day of April, 2023.
