M. Berkel explained that Proplant Propagation Services Ltd. in Jarvis is in the process of applying to the IESO for a cogeneration electricity plant, noting that both the heat and the electricity will be harvested. By combining the two efficiencies, it will allow for heat to be utilized as energy and the rest will be supplied to the local distribution grid with electricity. The process requires a municipal support resolution.
