Report ENG-13-2023 Renaming of a Portion of Haldimand Highway 54 to Caithness Street East

# **OBJECTIVE:**

To seek Council approval to rename a section of Haldimand Highway 54 to Caithness Street East within the limits of the urban boundary of Caledonia.

#### **EXECUTIVE SUMMARY:**

Staff are proposing to extend the limits of Caithness Street East eastwards from McClung Road to align with the Caledonia urban boundary and reflect the urbanization and development of this area. The road is currently named Haldimand Highway 54.

#### **BACKGROUND:**

Caithness Street East runs from Argyle Street North to 110 metres east of McClung Road where it changes to Haldimand Highway 54. To maintain consistency, staff recommend that Caithness Street East be extended to 530 metres east of McClung Road to align with the urban boundary and recognize the development and urbanization in the area.

The extension of Caithness Street East is shown in Attachment 1 to this report.

### **ANALYSIS:**

Renaming Haldimand Highway 54 to Caithness Street East recognizes the development and urbanization of the roadway in this area. It is also consistent with the current limits of the urban boundary of Caledonia.

There are three County owned parcels of land that will be impacted by the renaming, two of which are vacant lands that do not currently have a civic address. The third County owned parcel of land containing the McClung Sanitary Pumping Station will require changing the civic address to a Caithness Street East address. There are no other parcels of land that will be impacted by the renaming.

In order to rename this section of roadway to Caithness Street East, Haldimand County must enact a by-law that will include the following:

# FINANCIAL/LEGAL IMPLICATIONS:

Roads Operations will be responsible for installing the required signage. The estimated cost is approximately \$1,200 and will be funded from the Roads Operations regulatory/warning signage operating account.
