- Motion Re: Reconfirming the request that Municipal Affairs and Housing issue a Ministerial Zoning Order for lands in the Nanticoke area (Notice submitted by Councillor Shirton at the May 8, 2023 Council meeting)
- 1.1 James Kaspersetz Re: Recommended buffer zones around heavy industry
 - J. Kaspersetz spoke to the Nanticoke industrial area three-mile buffer zone, noting that it was established in 1972 based on research conducted at the time and was intended to attract industry to the area. To illustrate how air emissions are assessed today, he provided a sample model based on 2020 Stelco data that indicated that compliance is achieved at 1000 metres inside the Stelco property.
- 1.2 Marie Trainer Re: Lack of public transportation and current vacancy in ward 4
 - M. Trainer spoke to the concern about voting on the MZO prior to the Ward 4 byelection and recommended that the motion be deferred until there is a full council in place. The other issue relates to how increased traffic could make going to the new Active Living Centre more dangerous for children.

- 1.3 Trevor Harris, VP Corporate Affairs, Stelco Re: Legal ownership of affected lands and timing of draft motion
 - T. Harris noted that ownership of the lands is still subject to a court proceeding and recently, court indicated that Stelco may negotiate for purchase of the subject lands. Mr. Harris recommended deferring a decision on the matter and having staff report back on what was heard through the consultations. He also supported a deferral until there is a Ward 4 Councillor in place.
