Report ENG-24-2023 Winter Parking Control By-law Amendment - Ross Avenue, Dunnville

To receive Council approval to amend Haldimand County Winter Parking Control By-law 302/02 in order to make changes to the winter parking regulations on Ross Avenue in Dunnville.

#### **EXECUTIVE SUMMARY:**

Staff are recommending that a Snow Route be created on the east side of Ross Avenue in Dunnville to improve winter control operations in the area. This recommendation is in response to concerns raised by residents through the local Councillor and Haldimand County Roads Operations staff in regards to the ability to effectively meet the minimum maintenance standards during the winter control season.

#### **BACKGROUND:**

Ross Avenue is a local road that runs from Alder Street West to South Cayuga Street West in Dunnville. Staff have reviewed the existing parking regulations on Ross Avenue and parking is currently permitted on both sides of the road during the winter season from November 15<sup>th</sup> to April 15<sup>th</sup>.

Residents of Ross Avenue and Roads Operations staff have raised concerns that the on-street parking limits the ability for winter control vehicles to effectively clear the roadway given the road is relatively narrow.

#### **ANALYSIS:**

A Snow Route is a type of parking restriction permitted under the Highway Traffic Act that allows for winter maintenance while still permitting on-street parking for the residents during the day. Snow Routes

limit parking during the hours of 2:00 a.m. to 8:00 a.m. from November 15<sup>th</sup> of any year to April 15<sup>th</sup> of the following year.

Based on a staff review and consultation with Roads Operations staff, creating a Snow Route on one side of Ross Avenue will allow for effective snow clearing while maintaining on street parking when not restricted.

To create the Snow Route on the east side of the road the following amendment to Haldimand County Winter Parking Control By-law 302/02 is required:
