#### H. REPORTS

1 Monthly Reports from the Detachment Commander

Inspector Kays introduced Acting Staff Sergeant Yohnicki and provided an overview of his policing experience.

Subsequently, the May, June, July and August monthly reports were reviewed with the Board, adding that more fulsome reports will be provided moving forward. Analytics on the Mobile Crisis Response Team, marine patrol hours over the summer months, community engagement events and community street crime unit activities were highlighted. An update was provided on staffing within the detachment, noting that four administrative clerks, three members, and two special constables have been recruited.

Discussion ensued regarding detachment vacancies and recruitment, genderbased violence and domestic occurrences, and grant funding for the Mobile Crisis Response Team. Acting Staff Sergeant Yohnicki provided an overview of the Safe Streets Program which has been implemented in the County of Brant. The program is a community public safety initiative designed to help promote public safety, foster and maintain a safe downtown environment, deter unlawful behaviour, aid emergency responders, and provide support for police investigations.
