1 Ward Boundary Review - Update

Jack Ammendolia, Managing Partner, Watson & Associates Economists Ltd.

Dr. Robert (Bob) Williams, Public Affairs Consultant, Municipal Electoral Systems Expert

J. Ammendolia, Managing Partner, Watson & Associates Economists Ltd. provided an update on the Ward Boundary Review project.

Council asked questions and received answers from the consultant regarding the following:

- Whether consideration was given to adding an additional Councillor/ward either to Caledonia or at large;
- Potential adjustments to the ward boundaries around Caledonia;
- How the growth forecasts were calculated;
- Concerns regarding the size of the proposed Lakeshore Ward;
- Whether there was any consideration given to splitting the wards along the Grand River; and
- The perceived isolation of the Lowbanks area from the rest of the municipality.

Council asked staff for clarification as to the rationale behind the existing ward boundaries in Dunnville, and whether there are legislated timelines for making changes/adjustments to ward boundaries.
