Report ENG-02-2025 Parking Control By-law Amendments – Ouse Street North and Ouse Street South, Cayuga

### **OBJECTIVE:**

To receive Council approval to amend Haldimand County Parking Control By-law 307/02 to make changes to the parking regulations on Ouse Street North and Ouse Street South in Cayuga.

### **EXECUTIVE SUMMARY:**

Recent reconstruction efforts by Haldimand County on Ouse Street North and Ouse Street South, along with the Ministry of Transportation's work on Bob Baigent Park as part of the Highway 3 Cayuga Bridge Replacement project, have prompted a review of parking conditions in these areas. At the request of the local Councillor, staff have conducted an assessment and are recommending several changes to enhance parking accessibility and efficiency.

The proposed modifications include the proper by-lawing of localized angled parking and accessible parking spaces and the implementation of a 2-hour parking limit at the small parking lot on Ouse Street North. To enact these changes, amendments to the Haldimand County Parking Control By-law 307/02 are necessary.

#### **BACKGROUND:**

Ouse Street North and Ouse Street South underwent significant reconstruction projects between 2020 and 2022. At the request of the local councillor, a review of the parking conditions on both streets was conducted to ensure that the parking spaces are appropriately signed and that accurate by-laws are in place.

In 2020, Ouse Street South was reconstructed from Talbot Street to Tuscarora Street, including watermain replacement and road resurfacing. As part of that construction, the parking area at the pavilion was re-paved to allow for angle parking and included an accessible parking space.

In 2022, Ouse Street North was reconstructed from Talbot Street to Cayuga Street, including watermain replacement and storm improvements. The reconstruction included the addition of five angled parking spaces on the west side of Ouse Street North near the intersection of King Street. This parking area was created to improve access to the river and downtown businesses.

Concurrently, the Ministry of Transportation completed enhancements to Bob Baigent Park during the landscaping and restoration phase of the Highway 3 Cayuga Bridge Replacement project. These enhancements included river access improvements, the installation of a concrete walkway, landscaping, and on-street parking improvements, which added five angled parking spaces and one accessible parking space.

With the completion of these various reconstruction projects, it is now necessary to amend the Haldimand County Parking Control By-law 307/02. These amendments will formally incorporate the new parking changes and enable municipal enforcement to regulate parking effectively.

#### **ANALYSIS:**

Staff have conducted a review of the newly created on-street parking areas and recommend the following:

## **Ouse Street North (see Attachment 1):**

- There are five angled parking spaces on the west side of Ouse Street North that must be added to the Angle Parking section of the Parking By-law.
- These spaces are also recommended for a two-hour parking limit from 8:00 AM to 2:00 AM to encourage turnover and provide convenient access to local businesses, the river and nearby trails.
- The remaining parking restrictions in this section are already included in the Parking By-law.

#### Ouse Street South - Brant Street West to Talbot Street (see Attachment 2):

- There are five angled parking spaces on the west side of Ouse Street South that must be added to the Angle Parking section of the Parking By-law.
- One additional space is marked as accessible parking in this section and must be added to the Accessible Parking section of the Parking By-law.
- A 20-meter No Parking section exists between Brant Street and Talbot Street to facilitate sightlines and traffic operation. This must be added to the No Parking section of the Parking Bylaw
- The remaining parking controls in this section are already included in the Parking By-law.

#### **Ouse Street South - near Tuscarora Street West (see Attachment 2):**

- There are five angled parking spaces on the west side near the Cayuga Pavilion that must be added to the Angle Parking section of the Parking By-law.
- One additional space is marked as accessible parking in this section and must be added to the Accessible Parking section of the Parking By-law.
- The remaining parking controls in this section are already included in the Parking By-law.

To implement the proposed changes, the following amendments to the Haldimand County Parking Control By-law 307/02 are required:
