1 Overview of the Community Safety Services Team

Inspector Kays introduced the Community Safety Services Team.

1.1 School Resource Officer – PC Abigail Whitenect

Provincial Constable Whitenect, School Resource Officer, provided an overview of her role and responsibilities, engagement within the schools, and student programs.

1.2 Community Mobilization Officer – PC Jordan Foebel

Provincial Constable Foebel, Community Mobilization Officer, provided an overview of his role and responsibilities, the Mobile Crisis Rapid Response Team (MCRRT) program, types of mental health occurrences within the community, and engagement with community groups.

Provincial Constable Foebel responded to inquiries from the Board regarding MCCRT worker hours of coverage, grant funding, transfer of care and the risk assessment process.

1.3 Media Relations and Community Safety Officer – PC Patti Cote

Provincial Constable Cote, Media Relations and Community Safety Officer, provided an overview of her role and responsibilities, media releases, engagement with community events, and recruitment ambassador and peer support duties.

Provincial Constable Cote responded to inquiries from the Board regarding community watch and neighbourhood watch programs.

2 Overview of the O.P.P.'s Response to Operation 3D

Provincial Constable Leclair, Provincial Liaison Officer, West Region provided an overview of his role and responsibilities, mandate of the liaison team, and their engagement with community outreach/events.

Provincial Constable Leclair also provided an overview of Operation 3D (Detect, Disrupt and Deter), noting that the O.P.P. is working in collaboration with the Royal Canadian Mounted Police (RCMP), Canada Border Services Agency (CBSA), and other municipal partners to ensure border integrity.

- Community Street Crime Unit composition and activities;
- Overview of e-ticket warnings; and
- Process and response time for emergency and non-emergency calls for service.
