By-law Number /25

Being a by-law to amend By-law 307/02 - Parking Control By-law (Caledonia)

WHEREAS Section 10 of the *Municipal Act, 2001*, S.O. 2001, c. 25, as amended, (the Act) provides that a single-tier municipality may pass by-law respecting any services or things that the municipality considers necessary or desirable for the public;

WHEREAS in accordance with the Act, the Council of The Corporation of Haldimand County enacted the By-law 307/02 to regulate and govern traffic and the parking of vehicles on private property or municipal property in Haldimand County;

AND WHEREAS the Council of The Corporation of Haldimand County now deems it expedient to amend Schedule "B" No Stopping and Schedule "D" Restricted Parking of By-law 307/02,

NOW THEREFORE, the Council of The Corporation of Haldimand County enacts as follows:

1. **THAT** Schedule "B" No Stopping – Caledonia of By-law 307/02 be amended by deleting the following:

Caithness Street East	Both	Argyle Street North	70 metres east	Anytime

2. **THAT** Schedule "B" No Stopping – Caledonia of By-law 307/02 be amended by adding the following:

Street	Side	From	То	Period
Caithness Street East	North	Argyle Street North	38 metres east	Anytime
Caithness Street East	South	Argyle Street North	78 metres east	Anytime

3. **THAT** Schedule "D" Restricted Parking – Caledonia of By-law 307/02 be amended by deleting the following:

Street	Side	Area	Time	Period
Caithness Street East	Both	A point 70 metres east of Argyle Street North to Edinburgh Square East	8am to 2am	2 hours

4. **THAT** Schedule "D" Restricted Parking – Caledonia of By-law 307/02 be amended by adding the following:

Street	Side	Area	Time	Period
Caithness Street East	North	A point 38 metres east of Argyle Street North to a point 75 metres east of Argyle Street North	Anytime	15 minutes
Caithness Street East	North	A point 75 metres east of Argyle Street North to Edinburgh Square East	8am to 2am	2 hours
Caithness Street East	South	A point 78 metres east of Argyle Street North to a point 95 metres east of Argyle Street North	Anytime	15 minutes
Caithness Street East	South	A point 95 metres east of Argyle Street North to Edinburgh Square East	8am to 2am	2 hours

- 5. **THAT** this by-law shall take precedence over any by-law with which it is inconsistent.
- 6. **AND THAT** this by-law shall come into force and take effect when signage applicable to this provision has been installed and is on display.
