Purchase a portion of the road allowance, south of Front ( Tamarac Street ) that adjoins my property to the east. If that is not possible I would ask to have this portion of the road closed to pedestrian traffic. There is a local individual who has been harassing me and my husband for several years. He doesn't live in the neighbourhood. Someone told him that this is a road allowance and he uses it for access to property on the river that he doesn't own. Absentee owner from Hamilton. This person has just recently gotten off of probation for harassment and death threats to another family. This strip of land runs the entire length of my property from Front Street to the river and is 30 feet from my bathroom window. He stops and waves, sits at the river all day drinking. If we are outside he sometimes calls us names. My husband isn't well and this situation is nerve wracking. I managed to get his picture one day out of the bathroom window and sent it to Melissa Lloyd along with a copy of the probation order. He has already shown up this year. I've had the police here many times and nothing can be done because I don't own the property and it's an open road allowance. We would appreciate some relief from this situation. Thanks for your consideration.
